Eligibility for Fellowship: Nominee has had a minimum of eight years of professional experience, including not less than five years of work principally devoted to economic geology, three of which must have been in positions of responsibility. Consideration will be given to work of an individual in research or as a teacher of economic geology.

Application Procedure: An applicant must be sponsored by two SEG Fellows. The initial sponsor takes primary responsibility for completion and submission of the form, including identification of an appropriate second sponsor, and ensures that the candidate has provided a summary or resumé/CV of the applicant's principal activities in economic geology or contributions to exploration (MAXIMUM TWO PAGES).
